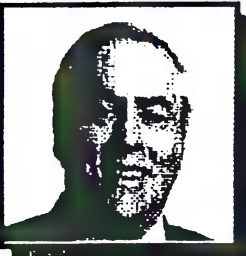




WHILE MAORI HAVE BEEN PATIENTLY WAITING FOR RETURN OF STOLEN LANDS AND RESOURCES, THE GOVERNMENT HAVE SOLD THEM TO OVERSEAS COMPANIES. THIS IS PART OF A WORLD WIDE STRATEGY BY THESE COMPANIES TO CONTROL THE WORLD ECONOMY. THE M.A.I. AGREEMENT IS AN INTERNATIONAL TREATY THAT WILL GIVE THESE COMPANIES MORE POWER AND ACCESS TO AOTEAROA. WINSTON PETERS AND NZ FIRST SAID THAT THEY WOULD STAND UP AGAINST MORE FOREIGN CONTROL IN OUR COUNTRY..... THEY LIED.



THE GOVERNMENT WANTS MAORI TREATY RIGHTS REMOVED BECAUSE THEY ARE AN OBSTACLE TO FOREIGN CONTROL. IN 1992 THE GOVERNMENT ALLOWED 43 MAORI INDIVIDUALS TO SIGN THE NOTORIOUS SEALORDS DEAL THAT TOOK AWAY THE COMMERCIAL FISHING RIGHTS OF THE ENTIRE MAORI NATION. A MAORI FISHERIES COMMISSION WAS THEN APPOINTED TO ALLOCATE THE BENEFITS OF THIS DEAL TO "IWI" THE COMMISSION HAS SPENT THE LAST SIX YEARS AND AN ESTIMATED 14 MILLION DOLLARS ARGUING IN COURT WITH OTHERS AS TO WHAT IS THE "IWI". MEANWHILE TAU HENARE WHO AS THE MINISTER OF MAORI AFFAIRS HAS THE POWER TO INTERVENE HAS SO FAR DONE NOTHING.



ENCOURAGED BY THE "SUCCESS" OF THE SEALORDS DEAL THE GOVERNMENT IS ATTEMPTING TO ENTER INTO DIRECT NEGOTIATION WITH "TRIBAL NEGOTIATORS" AND PANICKING MAORI INTO ACCEPTING A FULL AND FINAL SETTLEMENT OF ALL CLAIMS. UNDER THE TERMS OF THE FISCAL ENVELOPE MAORI HAVE TO ACCEPT NO OWNERSHIP OF NATURAL RESOURCES, A FRACTION OF THE MONETARY VALUE OF THE STOLEN LAND, NO RIGHTS TO TINO RANGATIRATANGA (MAORI SELF DETERMINATION). ..... OR NOTHING AT ALL



THERE ARE MAORI ATTEMPTING TO CASH IN ON THE DEALS BY PRESENTING THEMSELVES TO THE GOVERNMENT AS LEADERS OR CONSULTANTS OFTEN WITHOUT THE INFORMED CONSENT OF THE MAJORITY OF PEOPLE THEY SAY THAT THEY REPRESENT. THIS HAS ENCOURAGED COMPETITION AMONGST THEMSELVES AND FURTHER DISUNITY AMONGST MAORI. MANY OF THESE INDIVIDUALS GO ON TO BE APPOINTED BY THE GOVERNMENT ONTO BODIES THAT CONTROL THE MONEY LIKE THE FISHERIES COMMISSION AND THE CROWN RENTAL FORESTRY TRUST.

- IMPOSE A FREEZE ON NATIONAL ASSET SALES

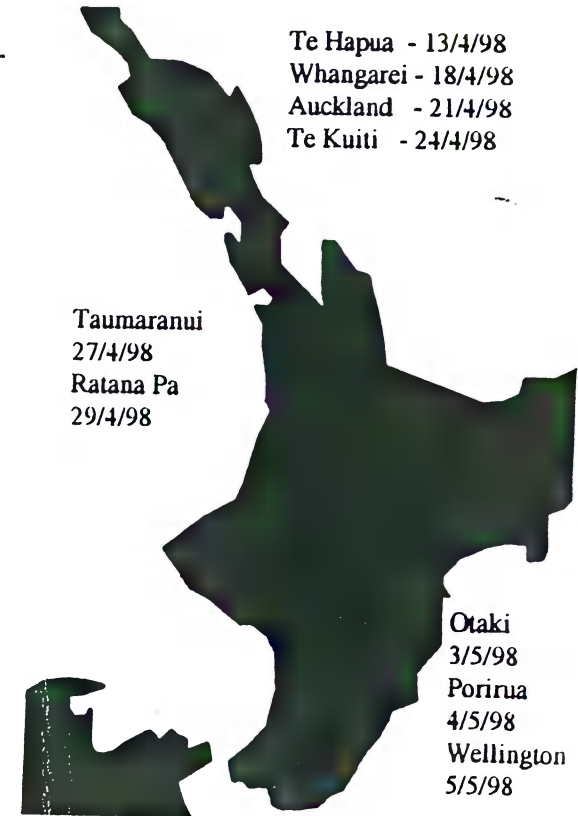
